The transport department is permitted to file documents to support the statement as to how many vehicles are required. The cap was fixed in 2011. What steps are taken thereafter to ascertain requirement and in the affidavit, it may also be mentioned objectively the over all requirement.

EPCA to submit a report as to how many vehicles can be permitted considering the environment aspect in case, the cap is lifted. The transport department to assist the EPCA to furnish relevant details of vehicles etc.
