REPORT NO. 106 SUBMITTED BY EPCA (Special Report on pollution hot spots in NCR with request for urgent directions to improve enforcement and pollution control)

IN RE: STUBBLE BURNING AND SMOG IN DELHI  
INTERLOCUTORY APPLICATION NO. 127792/2017(DISPOSED OF) (Application for direction submitted in Court by A.C. on 17.11.2017)

IN RE : COMPLIANCE OF ORDER DATED 13.01.2020

We are literally shocked at the attitude of the respondents with respect to installation of Smog Towers, which were supposed to be installed within three months and for which an agreement was to be entered into and the order was passed on 13.01.2020 after obtaining the requisite reports. Places were also chosen and stated on affidavit by the Central Government and the Govt. of NCT of Delhi. It was directed that the smog towers be installed within three months, but unfortunately, neither the Agreement has been entered into nor the requisite drawings have been obtained. The affidavit that has been filed is so much laconic and it is painful to note that the real intention is not to comply with the order of this Court and there is absolutely no respect shown to the order passed by this Court and for compliance of the order passed by this Court by the concerned respondents.

In the circumstances, we direct the MoEF and Govt. of NCT of Delhi to collect the drawings, in case the drawings have not been collected so far and to enter into an agreement positively within seven days and place compliance before this Court on the next date of hearing. In case the aforesaid directions are not complied with, we direct the personal appearance of the Secretary to the Government, MoEF and the concerned Secretary to the Govt. of NCT of Delhi on the next date of hearing, to explain as to why they have not complied with the order passed by this Court so far.

IN RE : PILING UP OF WASTE/GARBAGE BY THE SIDES OF RAILWAY TRACKS IN DELHI

We direct the Railway Department as well as the Municipal Corporations to comply with the order and to submit an action plan on the next date of hearing.

It is made clear that if the action plan is not submitted within the stipulated time, appropriate action will be taken against the concerned individuals.

List the matter in the first week of August, 2020 regarding Waste/Garbage.

Various affidavits filed by the State Governments will be taken up separately, except the matters of Delhi, Haryana, Punjab and U.P.

Let the matters of Delhi, Haryana, Punjab and U.P. to be heard together on 29.07.2020 along with the issue of Smog Towers.

It was rightly pointed out by Ms. Aparajita Singh, learned Amicus Curiae and senior counsel, that nothing concrete has been done so far. Meeting of all stakeholders is required to be held by the Central Government involving the States of Haryana and Punjab to work out the comprehensive plan of action. We direct that a

meeting be convened among the concerned high level officers and the Secretaries of the Ministry of Environment and Forest and Ministry of Agriculture with the Chief Secretaries of Delhi, Punjab and Haryana and a comprehensive plan be submitted to this Court on the next date of hearing.

INTERLOCUTORY APPLICATION NO. 181745/2019 AND 46339/2020  
(Applications for Intervention and Directions on behalf of Harshita Singhal)

With respect to Bio-medical waste, this Court passed an order on 06.03.2020 and issued notice to M/s Biotic Waste Solutions Pvt. Ltd. In spite of notice, they have not responded so far. It was pointed out by Mr. A.N.S.Nadkarni, learned senior counsel appearing on behalf of the applicant(s), that Bio-medical waste is being dumped in open in the nearby forest area, which is an objectionable act. It was also pointed out by Ms. Aparajita Singh, learned Amicus Curiae that Bio-medical waste is not being segregated and it is very dangerous, more so due to the pandemic of Coronavirus. As the bio-medical waste of the corona patients is mixed with that of general patients and thrown in open, the same is going to create havoc and its requisite treatment by Incinators and disposal is required.

Under the Bio-Medical Waste (Management and Handling) Rules 2016, the individual hospitals can enter into a contract only with the State Pollution Board approved Common Bio-Medical Waste Treatment Facility (the Contractor) who collects the waste from the

hospitals and manages the disposal of the waste.

The tracking of biomedical waste generated; collected; processed and recycled needs to be improved urgently by adopting the bar-code system, as specified in the 2016 Rules which has not yet been implemented completely. The following hospitals have not adopted the bar code system as per the EPCA Report :

1. Chhatrapati Shivaji Subharti Hosiptal, Subhartipuram, NH-58, Meerut
2. Paras Hospital, Plot No. 130, Sector 4, Vaishali, Ghaziabad
3. Lyf Hospital, NH- 04, Gyan Khand -I, Indrapuram, Ghaziabad

For the aforesaid purpose, we have requested Ms. Aishwarya Bhati, learned ASG appearing on behalf of the Central Government and Mr. Dinesh Dwivedi, learned senior counsel appearing on behalf of the Government of NCT of Delhi that let a meeting of the Central Pollution Control Board, Delhi Pollution Control Board and EPCA and the requisite stakeholders of the concerned Departments of the Central Government and Delhi Government and National Capital Region, including the representatives of the Corporations be called for urgently within three days from today and steps be taken with respect to clearing bio-medical waste of various hospitals and that of Corona patients.

Let notice be issued to the hospitals and they are directed to ensure that bio-medical waste is not dumped in the open area and properly segregated and disposed of. Let a concrete action plan be prepared in this regard with respect to bio-medical waste and be submitted to this Court before the next date of hearing.
